Message from Mr Martin Šustr, current Chair of the Prague Process

Dear Partners and Friends,

On behalf of the Czech Republic, current Chair of the Prague Process, I would like to briefly introduce myself and update you on some important developments within our migration dialogue.

Following some internal rotation, it is my privilege to take over the Chairmanship of the Prague Process from my predecessor Mr Tomáš Hach. My objective is to continue his excellent work and build on the achievements to further strengthen our collaboration.

In October 2022, our Ministers endorsed a joint Declaration and Action Plan for the period 2023-2027, thereby launching the fourth phase of the Prague Process cooperation. Following the commitment of the Prague Process states, the Czech Republic presented a concept to facilitate the timely implementation of the Action Plan, which received the overwhelming support of the Senior Officials' Meeting held in Lisbon in April 2023. Last summer, the European Commission agreed to provide funding for implementing the Prague Process Action Plan up until the end of 2027. On behalf of the Prague Process states, I wish to thank the European Commission for its financial support enabling us to further deepen our cooperation!

Our Action Plan calls for sustaining and expanding the three pillars of work the Dialogue, Migration Observatory and Training Academy – while calling for additional specific actions to address existing and anticipated challenges. The Questionnaire disseminated to the Prague Process states a year ago identified their priority interests and future contributions to the Process. Its findings translated into the newly launched Thematic Components, aiming to address the priority needs of the member states. The fourth phase of Prague Process cooperation will entail further innovative elements such as the Digital Lab and Resilience Hub thereby

involving more operational collaboration including modern technologies, digitalisation and capacity building.

In this regard, I am also happy to share with you that the capacities of the Prague Process Secretariat at ICMPD have been strengthened, which will enhance the fulfilment of our joint ambitions.

I very much look forward to your active engagement in the fourth phase of the Prague Process cooperation and hope to greet you in person during one of the upcoming activities. For now, I wish you a peaceful holiday season and a good start to a successful new year.

Study Visit to the Federal Office for Migration and Refugees of Germany

On 10-12 October 2023, the Federal Office for Migration and Refugees of Germany (BAMF) in Nuremberg hosted a Prague Process Study Visit. This visit constituted the first activity of Thematic Component 3 (Asylum), bringing together asylum practitioners, decision-makers and policy officials responsible for asylum from 13 countries. It provided a comprehensive insight into the work of the BAMF, including its legislative framework, institutional setting, operational practices and various innovative approaches to overcome the manifold challenges confronted.

Expert Workshop on the Potential of Digitalisation in the Migration Context

Upon the invitation of the Ministry of Justice of Georgia, the Prague Process organised the Workshop on the Potential of Digitalisation in the Migration Context in Tbilisi, Georgia, on 24-26 October 2023. The workshop gathered over 70 participants from 16 countries as well as the European Commission, EUAA, IOM, EU Delegation Georgia, Erasmus University to Rotterdam, and independent experts. It represented the first activity of the newly launched Prague Process Digital Lab, a designated area of work within the Prague Process Training Academy and Migration Observatory, which will explore digitalisation as a horizontal issue across the various thematic areas of the Prague Process Action Plan.

On 7-8 November 2023, the Prague Process organised the Kick-off Workshop under the Thematic Component 2: Promoting readmission, voluntary return and sustainable reintegration, in Tirana, Albania. The first activity on the topic gathered return experts from 19 countries as well as representatives from the European Commission, Frontex, IOM, ICMPD and JCP.

Exploring Migration Forecasting: Insights from the EMN Luxembourg Workshop



On 7-8 November 2023, the Prague Process Secretariat had the honour to delve into the intricate world of migration forecasting during the EMN Luxembourg Workshop "Forecasting and new Technologies in migration and asylum governance: states of play and new developments".

Bringing together various experts and stakeholders, this effort aimed to enhance predictive capabilities in migration, shedding light on the complexities of policy implementation. From cutting-edge studies on biometrics by Frontex and the EUAA Analytical Framework to ongoing negotiations on the Al Convention by the Council of Europe and OECD's stance on anticipating migration flows, the workshop covered a spectrum of perspectives. Prof Dr Robert Harmsen, Dean of the Faculty of Humanities, Education, and Social Sciences at the University of Luxembourg, set the tone by emphasizing the duality of policy instruments.

These instruments, both technical and functional, play a crucial role in shaping political power dynamics.

Country representatives from France, the Netherlands, and Norway shared their forecasting experiences, addressing challenges and emphasizing the need for flexibility. In many countries, forecasting involves both statistical modelling and expert knowledge allowing the development of several scenarios for consideration by policymakers. While forecasting migration flows related to labour or family migration is easier, anticipating forced movements is an A+ task. Moreover, forecasting results are often misinterpreted by policymakers who take the probability rates as fixed.

The panels also featured innovative projects, including the FLEE model by Brunel University London, an agentbased model for forecasting conflict-driven displacement, as well as the IT FLOWS Project, focusing on predicting migration using models and real-time data, including pull/push factors and risks of tension among migrants and receiving communities. The last two presentations of the Workshop shed light on the Migration Network Predictions, a model aiming to identify migration patterns by the University of Piraeus, and Data-Driven refugee support, an approach to understanding and addressing refugee needs, utilizing chatbots and scraping conversations

within Telegram groups to provide insights for both refugees and state officials, run by the University of Zurich.

The insights shared during the workshop contribute to ongoing discussions on refining policies, enhancing analytical frameworks, and developing effective strategies for managing migration in an ever-changing global landscape.

The 6th ICMPD International Border Management Conference gathered in Istanbul



On 6-7 December, the Prague Process joined efforts with other ICMPDfacilitated initiatives in organising the 6th International Border Management Conference in Istanbul. The conference, co-organised with the Ministry of Interior of the Republic of Türkiye, Presidency of Migration Management (PMM) and Directorate General of Border Management, gathered over 190 participants from border management agencies, as well as the representatives of donor and international organizations, academia, the private sector, and 15 ICMPD offices. The conference featured three panel discussions addressing the operational capacity of modern border management.

It provided an overview of key developments supporting enhanced interoperability or harmonised approaches to apply border management measures. The participation of different regions and countries and wider geographic scope of the event allowed to exchange ideas with a view to identify common ground for cooperation. The representatives of the fifteen Prague Process states attending the conference expressed their gratitude and satisfaction with the rich practical knowledge gained and the opportunity to exchange experiences with colleagues from the wider region.



Prague Process Secretariat meets GDISC Secretariat

On 12 December, the Prague Process Secretariat had the pleasure of welcoming representatives of the Secretariat of the General Directors' Immigration Services Conference (GDISC) in Vienna, who were joined remotely by the Czech Republic as the current Prague Process Chair and Poland as the GDISC Chair. Following the secretariats' first meeting in March 2023 in Nuremberg, they had an opportunity to follow up on their exchange, discuss possible synergies between the two intergovernmental platforms, and update each other on the latest activities and outputs as well as their plans for 2024.



The Prague Process e-Learning Platform: Available Courses

In 2021, the Prague Process Training Academy launched its e-Learning Platform, dedicated to providing educational resources for self-paced independent remote learning to the Prague Process states and partners. As traditional in-person learning faces limitations, e-learning tools emerge as a secure and effective alternative, offering professionals a convenient method to acquire, enrich, or refresh their knowledge on migration matters.

As of December 2023, the platform features four courses: Labour Migration, Identification and Profiling at the Border, Return and Reintegration, and the latest addition, Integrated Border Management. These courses are accessible in both English and Russian, allowing participants the flexibility to revisit and tailor their learning experience to fit their individual schedules without the concern of losing progress. Upon successful course completion, participants are awarded a certificate.

Access to all courses is granted upon registration on the platform. The Prague Process Secretariat actively encourages state representatives to seize this opportunity for capacity enhancement through remote learning. The New EU Pact on Migration and Asylum – the structural response to current challenges

In June 2023, under the Spanish EU Presidency, Ministers of Justice and Home Affairs agreed on crucial legislation files stepping up efforts to finalize the EU migration and asylum policy reform. Interior ministers agreed on a compromise text of the proposals for the Asylum and Migration Management Regulation (AMMR) and the Asylum Procedure Regulation (APR).

A key legislation file, APR establishes a common procedure for Member States to follow when granting international protection and introduces mandatory border procedures. AMMR, once agreed with the co-legislator, replaces the current Dublin regulation determining the member states responsible for asylum applications and proposes a new solidarity mechanism combining relocation, financial contributions, or alternative solidarity measures such as deployment of personnel or measures focusing on capacity building. On October 4, EU member states representatives reached an agreement on the negotiating mandate on a regulation on crisis situations, including instrumentalization of migration and force majeure in the field of migration and asylum (Crisis Regulation) that represent the final component of the new Pact. Additionally, the European Parliament has linked the progress of ongoing discussions about Eurodac and screening regulations to the approval of the Council's negotiation mandate for the crisis regulation. With the last legislation puzzle in place, the EU's New Pact on migration and asylum is almost complete. The Commission's 2024 Work Programme, adopted on 17 October 2023, declares that the Pact remains the structural response required for the EU to tackle migration challenges in the future while stressing the need to reach an agreement with the Parliament before the end of the current legislative term.

Frontex Status Agreement with Albania and its contribution to containing irregular migration

On September 15, the EU and Albania signed a new agreement on operational cooperation in border management with the European Border and Coast Guard Agency (FRONTEX) on the margins of the Berlin Process meeting of Interior Ministers in Tirana. Building on the EU's Action Plan on the Western Balkans and its operational measures, strengthening the joint operations, and FRONTEX deployments along the EU's external borders with Albania should contribute to addressing irregular migration and enhancing the security at the EU's external borders. Under the new Status Agreement, FRONTEX Standing Corps officers could be deployed at the borders between Albania and its Western Balkans neighbours, also contributing to cross-border crime prevention and irregular migration management.
